# **A. General Points**

The publisher usually does the layout editing. Before submitting your manuscript check the following format specifications. Please submit your text as a DOC file *and* as a PDF file. Do *not* use manual or automatic hyphenation. To place and administer footnotes, use the footnote function of your word processing program only.

# **B.** Spelling

French articles can be written either in old or in new French orthography (*Rectification de l'orthographe du français* 1989/1990) as long as spelling and punctuation are consistent within the contribution. English articles can be written either in British or in American English as long as spelling and punctuation are consistent within the contribution. In case of doubt, the editors will unify spelling and punctuation according to the one which is predominant in the rest of the contribution.

# **C. Typeface and Emphasis**

Font: Times New Roman (main body: 12 pt, 1.5 line spacing; footnotes: 10 pt, single-spaced; and indented quotes: 11 pt, single-spaced).

Emphases in *your* text should always be highlighted in *italics*. Other Emphases within *quotations* (as **bold type** or letter spacing) should be adopted unchanged if possible (otherwise, e. g. Schwabacher in black letter, this should be indicated in a footnote). Words can be labelled as terms using single chevrons (<>).

Be sure to distinguish consistently *in the continuous text* (main body *and* in footnotes if necessary) between separately published titles (highlighted *in italics*) and titles published in anthologies, <Taschenbüchern>, journals, etc. («regular in double chevrons»).

## **D.** Quotations

Double chevrons should be used to highlight quotations («»). All quotations must be identical with the source in every detail of orthography and punctuation. Variations are marked by square brackets ([]), omissions are marked by [...]. Quotations which are longer than three lines appear as a separate block, without chevrons, and indented by 1 cm. Verse quotations which are longer than *one* verse are always indented by 1 cm and labelled as such. Quotations within quotes are marked by single chevrons (<>).

Use footnotes to indicate the source of all passages taken from other texts clearly and separately (do not use <collection footnotes>!). Be sure to distinguish between referring to exact quotes (without «cf.») and quotes in spirit (with «cf.»). Quotations and references should *always* contain accurate page references (do not use pp.), if the text cited is longer than two pages. One following page is marked as «f.», e. g. «pp. 26f.».

If a work is cited for the first time, please use the complete reference. If it is cited more than once, a short form – author name and a reference to the footnote citing the work for the first time – can be used in the footnote. *If* there is a list of references, the short form may contain author name and short title only. If a quotation is from the same source as the *previous* one, «ibid.» is used instead of the author's name. Be sure that the reference is unambiguous!

## E. Bibliographic references

Use diplomatic title recording *without* bibliographic standardisation for all sources of the long 19<sup>th</sup> century (and earlier if necessary) excluding alignment, font size, font type, font co-lour, and the alternation of black letter and roman type.

### **F.** Figures

Send your image files as uncompressed TIFF at a nimum resolution of 300 dpi (line art with 1200 dpi). Please ensure that the image size of the file complies with the figure's printing size (e.g. with a type are of 13 cm the image size of the file needs to have at least a width of 13 cm and a resolution of 300 dpi).

Please number your illustrations consecutively. The caption should contain complete details of the source.

Example caption: Fig. 16: Jllustrirte Zeitung Nr. 1. Leipzig, Sonnabend den 1. Juli. 1843, S. 4/5. Copy of the University Library Duisburg-Essen (signature: D 06/01 Z 88).

If your images are not within the public domain, the responsibility for securing the permissions that may be needed for reproduction (including any expenses) *usually* lies with you.
